SOUTH CAROLINA YOUNG FARMER CHAPTER PRESIDENT AWARD

Purpose:

The Young Farmer Chapter President Award is designed to recognize outstanding leadership from local chapter presidents. Through individual and chapter participation in state and local events, and through planning and organization, this award is designed to strengthen the state association as well as the local chapter.

General Rules and Regulations:

1. Any Chapter President of a chartered South Carolina Young Farmer chapter is eligible to enter.
2. The South Carolina Young Farmer Executive Committee is not eligible to participate.
3. This award is to be judged on a twelve-month period, to be completed by the most recent president at or near the end of his tenure in office.
4. Complete entry form and mail to State Advisor no later than November 1.
5. The Young Farmer State Executive Committee will determine the State Winner.
6. All awards will be presented at the State Young Farmers' Convention.

Awards:

\$100 cash and engraved plaques to each district winner

Additional \$100 cash to State winner
